The purpose of this onsite meeting and non-professional consultation is to provide guidance that will reduce the risk that projects will be implemented in a manner that fails to comply with the Hazardous Fuel Treatment Standards that have been adopted by the Gold Mountain Homeowners Association. In all cases, our joint goal is to preserve the natural beauty of Gold Mountain while taking prudent steps to reduce the risk of devastating wildfire damage.

This consultation is not necessary for routine or recurring maintenance of hazardous fire fuels done by property owners.
